Event Details

After a great event in 2017, the Annual Meeting of the Mississippi Society of Health-System Pharmacists is meeting again at the Oxford Conference Center in Oxford, MS. On behalf of the MSHP Education Committee, I hope that you will consider joining us in Oxford for continuing education (CE), networking opportunities, and some well-deserved downtime. This year, there will be a special opportunity to learn more about the Practice Advancement Initiative in the Ambulatory Care setting during a 4-hour workshop held the morning of July 26th, with the general meeting beginning that afternoon with 3 hours of Pharmacist CE.

A total of 13 Pharmacist-hours and 6 Pharmacy Technician-hours of CE will be offered with the opportunity to complete the education required to earn or maintain a Mississippi Consultant Pharmacist Certification and Pharmacy Technician Law. The continuing education offerings this year will include a broad array of topics and feature speakers from a variety of settings.

This year, the exhibits and silent auction will open at the Oxford Conference Center after the opening day's educational sessions. Food and beverages will be provided during the exhibitor showcase. The awards banquet and officer installations will be held on Friday, July 27th. Immediately following the education sessions on Friday, attendees will have an opportunity to enjoy a reception hosted by MSHP and the University of Mississippi School of Pharmacy at The Chancellor's House. Shuttle service will be provided to The Chancellor's House and from the square on the evening of the reception.
